

Enclosed please find the Show Schedule, Entry Form, and Rules & Regulations for the 2017 TWHEAO Summer Extravaganza Show.

- RV Spaces – They are on a first come basis, no specific spot is reserveable. Your fee covers Friday night – Sunday mid day. If you will be arriving early or staying Sunday night, the fee is an additional \$20.00 per night, mark your form accordingly.
- There are several hotels in the area but events that weekend may mean limited hotel/motel availability. Book early if possible. Suggestions McMinnville Inn or Motel 6 McMinnville.
- The stall fee covers Friday pm until Sunday pm after the show. If you plan on arriving prior to Friday afternoon make sure you mark your entry form accordingly so we can pass on to the facility that information. Early arrival or late departure will be charged extra \$20.00 per stall per night.
- Yamhill County Fairgrounds is a NON SMOKING facility. The facility will be enforcing this and has requested that TWHEAO also assist in enforcing this rule.
- By signing the attached entry form you agree to abide by all rules and regulations listed in this premium.

GENERAL INFORMATION

- Should TWHEAO receive a bill for any early arrivals or late departures that were not collected, you will in turn be billed double the fee, along with a billing fee of \$30.00. By signing the entry form you agree to these rules.
- Dogs accompanying exhibitors and trainers must be kept on a leash at all times, please no loose dogs. You must clean up after your pet, any complaints filed and you will be required to confine your dog.
- The warm up arena is off limits for visitors. It is small and during the show is very congested. For personal safety, please respect this rule.
- All riders 13 years of age and under are **required** to wear protective helmets whenever riding and/or showing on the horse show grounds. **This includes the lead line class.**
- Horses are only allowed in the barn/warm up arena and in the main arena.
- Please clean up after yourself and your horse. Areas left messy after the show will be charged to the organization and subsequently you will be billed whatever the facility charges (minimum of \$40), plus an additional billing fee of \$30.00.
- The facility monitors closely to ensure there is no smoking in the facility. Show management will assist in enforcing this. Anyone found smoking in the facility is subject to up to a \$500 fine and/or removal from the show.

Entry and Class Information

- Entries must be postmarked by the closing date, **June 1st for the secretary to prepare the stall chart so the facility can have stalls ready.** If you cannot make this date, please contact the Show Secretary Kristina Cathcart, 541-829-3096 to provide stabling details, we reserve the right to waive late fees if we are contacted in advance. Entries postmarked after the mailing date, which have no prior arrangements made, may be subject to late charges.
- **Visa and Mastercard** will be accepted for all fees with number pick up. We also have the ability to process credit/debit cards for your show bill.
- If paying by check, do not mail it, provide it to the show office when picking up your number. Payment info is required before any exhibitor numbers are released. If you mail a check, you are doing so at your own risk. Checks will not be deposited until after the show.
- For TWHEAO insurance purposes, all horses exhibited must have a stall. There will be no working out of trailers.
- The Show Office will require a copy of the horse's Registration papers, **front and back**, for all Tennessee Walking Horses, TWH classes. It is a USDA requirement to have this information available. Be sure to send a copy with your entry or provide them when picking up your number(s). If the horse is being leased, provide a copy of your lease agreement.

- Management reserves the right to refuse, accept conditionally, to cancel entries, disqualify exhibitors, prohibit exhibition of entries and cancel premiums without claims for damage. Any individual who exhibits disorderly conduct or non-sportsman like conduct may be asked to leave the grounds and all high points associated with that person (individual points or horse points) will be null and void.
- All amateurs and youth **must** have current amateur or youth cards issued by WIWHA or WHOA. A number will not be assigned unless a valid card number has been issued or an application has been turned in, with payment to WIWHA, to the show secretary. If you do not have an Amateur Card, we will assume that you are a professional and must have a current Trainers card.
- The trainer of the horse must sign all entries. If you do your own training you must sign as the trainer.
- To receive Pre-Entry refunds, a phone call to the secretary will do.
- Persons failing to pay their bill in full and/or returned checks will be assessed a \$50.00 service fee. If not paid promptly, the bill will be turned over to WIWHA for suspension for non-payment. Those on suspension will not be allowed to show at WIWHA affiliated shows and high points earned will not be awarded.
- Please list all riders for each horse on the entry form. If additional space is needed please attach form to the entry.
- All classes will be conducted by the rules of WIWHA, and the TWHBEA Versatility Rulebook.
- All attempts will be made to combine one horse classes with other similar classes; if one horse classes are run they should be sponsored.
- When classes are entered and the horse does not go in the class, the class must be paid for unless the class is canceled or a scratch slip is filled out and in the office before the class has been called by DQP. No refund for any class when the horse is excused by DQP, excused by the judge, or self-excused once you entered the ring.
- **Entries made while going through DQP or at the office once the session has started, rather than in advance of that session, may be subject to a late assessment of \$20.00 per class unless a valid excuse is given.**
- Gate holds (3 minute maximum) will be granted for just cause upon notification of the Paddock announcer.
- Reminder: All horses presented for DQP inspection must have saddles removed prior to being inspected and all winners must unsaddle prior to post-show inspection **at the discretion of the DQP**. If necessary to remove saddles, there will be a designated tack area near the DQP station. Please bring a marked saddle rack with you. For the safety of all exhibitors, saddle racks will only be allowed in the designated tack area.
- If exhibitors plan to stay in the warm up area for more than one class, they must check in with the DQP Secretary for all classes they are staying in for.
- No chains or action devices are allowed to be used on any flat shod horses or horses that will be shown in any flat shod class at the show.
- Trail Pleasure and Country Pleasure classes are **Amateur Only**. With the exception of non rail classes
- TWH Pleasure classes are open to any flatshod horse (Trail Pleasure and Country Pleasure horses shall be ridden by an amateur or youth rider). Country Pleasure horses in a TWH Pleasure class must abide by the rules of the WIWHA Country Pleasure division. Country Pleasure horses to be designated by a mark on the back number for judge's identification.
- Novice – not to have won more than three (3) blue ribbons at any affiliated show.
- All Day Pleasure classes are OPEN to any gaited horse, any gaited breed, registration not required. No cross entry between Plantation and LiteShod TWH classes with All Day Pleasure classes.
- The judge may grant time-outs when the exhibitor pulls into the center of the arena. Time-outs will be granted for replacement of shoes, replacement of broken equipment, or in other instances, where the judge finds valid reason. An exhibitor may be excused from the ring by pulling into the center of the arena and obtaining permission from the judge or ringmaster. If you are excused, for any reason, you will be required to report to DQP for re-inspection.
- WIWHA, The Tennessee Walking Horse Exhibitors Association of Oregon (TWHEAO), the TWHEAO Show Committee, and Yamhill County Fairgrounds will not be responsible for any articles that may be lost, destroyed or stolen, although every precaution will be taken to protect property and exhibitors. The show or management will not be liable for any injury sustained in any way to exhibitors, animals, employees or spectators. **The warm up arena is not open to visitors;** you must be an owner, rider, trainer, or groom to be in the area.

- Ribbons to five places in all classes. Awards for first place. Highpoint Youth, Amateur and Trainer

STALL ASSIGNMENTS

As a reminder to all attending the horse show, **stall assignments are created by the Show Office. The posted stall assignments are final, unless special permission is granted to change your stall assignment.** Stall changes must be approved in advance of change and at the discretion of the stall manager. Changing stall assignments without approval from the Show Office may result in a fine of \$100 per stall.
