### **Affiliation/Inspections**

The Oktoberfest Horse Show is affiliating with WHOA HIO this year. We will be using the WHOA flatshod rulebook and this can be found through the WHOA website at <http://www.walkinghorseowners.com/>. The TWHBEA Versatility Rulebook (2010 and beyond) will be used for the versatility classes and is available at <http://www.twhbea.com/11PDFs/11TWHBEAVersatilityRuleBook2010Revision3.pdf>. Oktoberfest will again be participating in the Western States Walking Horse High Point Program. The cost of participation in this program will be borne by the show.

Oktoberfest will be affiliated with the Missouri Fox Trotting Horse Breed Association and the Bay Area Fox Trotter Association. All MFT classes will be eligible for the MFTHBA and BAFTA Hi Point Programs. Please see [www.mfthba.com](http://www.mfthba.com) for the current rulebook.

There **will** be a DQP on the grounds. **IF YOU ARE NOT SOUND, TURN AROUND!!** There is a zero tolerance policy in place for violations of the Horse Protection Act.

### **Class Schedule Changes**

**Class number 101 will be the Chris Ishmael Memorial Class.** This class is in memory and honor of Chris Ishmael, son of Kerry and Candy Ishmael. A special trophy will be awarded in Chris's memory and honor. All proceeds from this class will be donated to **Mission 22**. Every day in America, 22 veterans take their own lives. Mission 22 is a non-profit organization dedicated to raising awareness, enlisting support, and working to end veteran suicides in America. If you cannot show in this class, **please consider making a donation to Mission 22 in Chris's name at the show office.** Show management will have paperwork for the tax deduction.

All youth classes are now scheduled for Saturday and Sunday, to allow our youth exhibitors to attend school on Friday and still be able to show.

Versatility classes have been moved to Saturday afternoon. We are always thrilled with the large number of entries that participate in versatility and want to make sure there is no rush to getting all the classes completed.

### **Versatility High Point Award**

The Delight's Hi Tone Perpetual Versatility Hi Point Trophy will again be awarded to the hi point versatility horse. A reserve hi point will also be awarded. **No preshow sign up is required** and there are no specific rail class requirements. The points will be awarded in classes 75-86. However, points will only be counted for one class in each division, even though you are welcome to enter both classes. So a horse can earn points in class 75, 76, or 77, 78 or 79, 85 or 86, and 87 or 88. Points will follow the horse. All versatility classes remain only \$15 each to enter! The versatility classes have been changed to Saturday night. We are also pleased to offer **Cowboy Dressage tests with a special guess Cowboy Dressage judge, Susan Tomasini.** The classes will be run in the warm up arena and will start as soon as the arena can be set up following the Saturday morning session. Tests will continue as the other versatility classes are held in the main arena and entries may show as they are able. There will be no assigned ride times. ## **NCWHA Members Hi Point**

The NCWHA Members Oktoberfest Show Hi Points were well received last year and will continue to be “true” hi points with no class limits. **No pre-sign up is required!** If you are an NCWHA member **at the beginning of the show**, you are automatically eligible for this program. We will give hi point and reserve hi point awards in Open, Amateur, and Youth divisions. **Points follow the rider.** Because of this, we ask that the rider’s information be accurate for each class so points can be correctly assigned. This year, in order to be eligible, the member must show in at least one championship class. Also, only a max of three versatility classes will count toward points. More than one horse can be used to collect points.

## **Championship Classes**

As a special incentive to get more championship class entries, all championship class fees will stay at \$15. **There is a change to the Overall Championship Class this year**, due to low numbers showing back in the final class. The TWH judge will be given 10 cards. She will be distributing those cards throughout the show to the entries she feels are among the best of the show. **These ten entries will be invited to show back in the Overall Championship Class**. All ten entries will be awarded with Top Ten Overall prizes. The top five will be tied, with champion and reserve champion for the show being awarded. It is our hope that this will recognize the top horses of the show, regardless of division, and encourage them to show back in the final class to make it a more exciting class and a true overall championship for the show.

## **Barn Decorating Contest**

We are pleased to again offer the Barn Decorating Contest. First and second place will be awarded. Come up with a creative way to decorate your barn! There is no theme for decorations this year.

**Release of Liability and Indemnification:**

I expressly waive any rights I may have under California Civil Code Section 1542, which states that "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him, might have materially affected his settlement with the debtor."

I agree that I will indemnify and hold harmless Indemnitees against all claims, demands and causes of action, including court costs and actual attorneys' fees incurred, arising from any court proceedings or other causes of actions brought by or prosecuted for my benefit, in which this Release of Liability and Indemnification is upheld.

**I acknowledge that horseback riding is a sport which carries inherent risks of injury and damage to me, the Horse and my property. I knowingly assume all risks of participating in horse-related activities and horseback riding, whether known or unknown, including, but not limited to, injuries, death or property damage from: mounting, dismounting, riding, walking, grooming, feeding, use of facilities or riding arena, falling off a horse, riding without a helmet, or otherwise relating to horseback riding or otherwise use and control of, or lack thereof, of the horse ridden or any horse present at the Show. 1. Pre-entries must be postmarked by the closing date of **Friday, October 9, 2015**. Pre-entries may also be made through [www.horseshowtime.com](http://www.horseshowtime.com). Pre-entries may pay for entries by check if they are sending in an entry blank or by PayPal if entries are made via [www.horseshowtime.com](http://www.horseshowtime.com). Pre-entries also have the option of leaving an open check with the show office. The show closing date not only allows time for the office staff to prepare your entries properly, it also gives us the information needed by the fairgrounds to prepare stalls. By contract we must give them the amount of stalls needed several days before the show. Please try to get your entries in early.
2. Any original entries made after the closing date will be assessed the fee of \$30 per horse. **No exceptions.**
3. Payment in full or a signed blank check must be included with the entry to cover all show fees (Make checks payable to NCWHA Oktoberfest). Blank checks may be given to the show office at the show but must be received prior to obtaining the entry show number. Show numbers will not be issued until the entry is complete, **including NCWHA signed releases.**
4. Scratches and adds may be made at the show without an additional fee once an original entry is made. **In order to prepare for each session, NO ORIGINAL ENTRIES WILL BE ACCEPTED 30 MINUTES PRIOR TO THE START OF EACH SESSION. NO EXCEPTIONS.** Please also try to ensure all adds, scratches, and rider changes are made 30 minutes prior to each session.
5. The trainer of the horse must sign all entries. If you do your own training, you must sign as the trainer.
6. Please list all riders for each horse on the entry form. If additional room is needed, please write it on a separate sheet and staple it to the entry form.
7. Persons failing to pay their bill at the show will be charged a \$50.00 service fee. A \$50 service fee plus additional bank charges will be added to all returned checks. If accounts are not settled after billing, the NCWHA may pursue collection via Small Claims Court.
8. The listed stall and tack room fee covers Thursday night through Sunday afternoon. **Early arrivals and late stays for horses need to be arranged beforehand with show management. Please contact Rhonda Azevedo or Kris Herman.** Please indicate your arrival date on the entry forms.
9. Should Northern California Walking Horse Association receive a bill for any early arrivals or late departures that were not collected, you will in turn be billed double the fee, along with a billing fee of \$30.00. By signing the entry form you agree to all of the rules set forth in this Show Premium.
10. All straw stalls will come with "1" bale of straw. The straw will not be spread out. If you need additional bales of straw please make arrangements with show management ASAP. Shaving stalls are available for an additional fee. Shavings will NOT be provided.
11. Management will do its best to honor your stabling requests on your entry forms. However as a reminder to all attending the horse show, stall assignments are created by the Show Office. The posted stall assignments are final, unless special permission is granted to change stall assignments. If anyone is found changing stall assignments without receiving approval from the show office, they are subject to a \$100 fine per stall assignment that has been changed. We are very sorry to have to impose this strict of a rule, however, moving just one stall assignment, without approval from the show office, can create a stall chart nightmare and if your stall had been prepared, the association may be charged for it even if it is not used. We appreciate everyone's cooperation and understanding.
12. Working out of trailers is permitted. You will, however, be charged \$15 per horse, per day.

**Show Rules:**

1. **All TWH classes will be conducted by the rules of the WHOA Rulebook and TWHBEA Versatility Rulebook (2010 and beyond)**, which will be available to view at the show office. The WHOA rulebook is also available online at <http://www.walkinghorseowners.com/wp-content/uploads/WHOA-Rulebook-Flatshod-1.pdf>. The TWHBEA Versatility Rulebook can be found at [www.twhbea.com/programs/versatility.php](http://www.twhbea.com/programs/versatility.php). Any show rules that are different from what is listed in these rulebooks are specifically stated in this premium and will supersede any conflicting rules stated in either rulebook. Peruvian Paso classes will be conducted by the rules of the North American Peruvian Horse Association, available at <http://www.napha.net/new/ShowRules/ShowRules.pdf>. Missouri Fox Trotter classes will be conducted by the rules of the Missouri Fox Trotter Horse Breed Association, available through [www.mfthba.com](http://www.mfthba.com). Cowboy Dressage classes and tests will abide by the Cowboy Dressage rule book. Tests and rules available at <http://cowboydressageworld.com/>.
2. Lite Shod classes at Oktoberfest shall be governed under the rules of the Lite Shod Pleasure division in the WHOA rulebook. The shoe in this division is limited the ½"x1".
3. TWH Pleasure Division: Open to all Tennessee Walking Horses of all divisions.
4. As per the WHOA rules, Country Pleasure horses must be keg shod. Country Pleasure horses may be ridden by professionals in TWH Pleasure and OGB classes. Country Pleasure divisional classes are still amateur.
5. All Day Pleasure is an **amateur only division**. All gaited breeds are eligible. **Horses owned by professional trainers or their immediate family are not eligible for this division, unless the horse is used EXCLUSIVELY as a lesson horse by the trainer.** Crossover of TWH between All Day Pleasure and other TWH divisions is not allowed. All Day Pleasure shoes may be up to ½"x1 ½" as per WHOA rules. All Day Pleasure horses may also be ridden in TWH

Pleasure and OGB classes but must be ridden by an amateur rider. Please see the WHOA rulebook for information on the standards of this division.

6. Cross entering between TWH divisions is not allowed. All TWH divisions are eligible to show in OGB and TWH Pleasure classes.
7. The maximum shoe size allowed in the SSH classes is a liteshod shoe (1/2"x1").
8. All classes are exclusively for the registered Tennessee Walking Horses, with the exception of the All Day Pleasure, OtGB, SSH, & OGB classes which are open to non-registered gaited horses.
9. **Class definitions:** OGB (Open Gaited Breed)- All gaited breeds are eligible to show in these classes. There are no shoeing restrictions (exception: OGB barefoot classes). Horses may be registered or unregistered. Horses will be judged against the standard of their breed or TWH division. OtGB (Other Gaited Breed)- All gaited breeds EXCEPT Tennessee Walking Horses are eligible to show in these classes. Spotted Saddle Horses that are also registered Tennessee Walking Horses may enter OtGB classes but CANNOT cross enter into any TWH Pleasure or TWH divisional classes (lite shod, trail pleasure, country pleasure). Spotted Saddle Horses who are dual registered may cross enter in SSH classes. Horses may be registered or unregistered. Horses will be judged against the standard of their breed. Youth- Exhibitor is 17 years of age or under as of January 1, 2015. Limit- No more than 7 blue ribbons (1<sup>st</sup> place) won by horse/rider prior to the start of this show. Blue ribbons won when the horse/rider was the single entry in a class does not count toward the maximum total. The total does count all blue ribbons won in all HIO affiliated shows. Green As Grass- Horse or Rider is either in his or her first year of showing or has shown at fewer than five (5) shows lifetime. Green As Grass horses and riders must also fall under the definition of limit as above. Horses of Color- Open to horses of any unique color (Champagne, Buckskin, Palomino, Tobiano, Sabino, Roan, Gray, etc.). Chestnut, black, and bay horses are not eligible. Amateur Owned and Trained (AOT)- Horses must not have received professional training for 90 (ninety) days immediately preceding the show. AOT horses may not be ridden by a professional at any time on the show grounds. Amateur- Unless marked specifically 18 and over, amateur classes are open to youth and adults who meet the definitions of an amateur as per the WHOA rulebook V H. Pro/Am- Trainer to ride the first direction, amateur exhibitors to ride the second direction.
10. A versatility hi point award will be awarded to the entry who earns the most points in designated versatility classes. A reserve hi point award will be awarded to the entry with the next highest number of points. Points will be awarded based on placing (1<sup>st</sup>=6pts, 2<sup>nd</sup>=5pts, 3<sup>rd</sup>=4pts, 4<sup>th</sup>=3pts, 5<sup>th</sup>=2pts, participation=1pt.) and will follow the horse. A tie will be broken by most blue ribbons won. No preshow sign up is required and there is no fee to participate. The points will be awarded in classes 75-86. Points will only be counted for one class in each division (class 75, 76, or 77, 78 or 79, 85 or 86, and 87 or 88). Points will follow the horse. The show management will automatically count points in the class where the entry placed higher if both divisional classes were entered. Points for the versatility hi point may be earned by both team participants in the Ribbon Race class
11. Open, amateur, and youth NCWHA members hi points will be awarded. Points will follow the rider and the rider may use multiple horses. The rider must be an NCWHA member as of the beginning of the Oktoberfest Horse Show. There is no fee to participate. No pre-entries are required. A member must show in at least one championship class to be eligible and a max of three versatility classes may be counted for points. Points will be awarded based on placings as follows: 1<sup>st</sup>=6pts, 2<sup>nd</sup>=5pts, 3<sup>rd</sup>=4pts, 4<sup>th</sup>=3pts, 5<sup>th</sup>=2pts, participation=1pt. Ties will be broken by the most blue ribbons won.
12. Stallions shall be barred from Youth Exhibitors Classes.
13. The Leadline class is open to riders 6 and under. **All entries must be lead by an adult exhibitor.** One or two side walkers are acceptable as needed for rider safety.
14. Management reserves the right to cancel or combine any class with less than three (3) horses entered.
15. When classes are entered and the horse does not go into the class, the class must be paid for unless the class is canceled or a scratch slip is filled out at the show office prior to the start of the class. No refund will be issued when the horse is excused by the three person panel, excused by the judge, or self-excused once entering the ring.
16. Gate holds (3 minute maximum) will be granted for just cause upon notification of the Gate Person.
17. To qualify for a championship class, the horse must have been shown and judged in a corresponding qualifying class.
18. All horses that place 1<sup>st</sup> or 2<sup>nd</sup> in any halter classes qualify to show back in the halter championship.
19. The TWH judge will hand out cards to entries during the show (ten cards total). Only those entries receiving cards will be eligible to show back in the Overall Championship class.
20. Time-outs may be granted by the judge when the exhibitor pulls into the center of the arena. Time-outs will be granted for replacement of shoes, replacement of broken equipment, or in other instances where the judge finds valid reason. An exhibitor may be excused from the ring by pulling into the center of the arena and obtaining permission from the judge or ringmaster to be excused. Entries that are excused prior to the completion of the class will be deemed not judged and therefore that class will not qualify the entry for a championship class.
21. **All exhibitors, owner, and trainers must comply with the Horse Protection Act and cooperate fully with representatives enforcing that Act. Horses with any bilateral hair loss, scarring, callous, or granulated tissue on the pasterns or coronet area indicative of the practice of soring, showing signs of lameness, or any way of going that is considered "bad image" will be excused from classes entered and may be asked to leave the grounds. All entries must be inspected by the DQP. In addition, concerns of possible HPA violations may be brought by the**

judge or show management or by exhibitors filing complaints as per the WHOA rulebook and will be subjected to additional inspection. Show management may ask any entries in violation of the HPA to leave the grounds. Any person with ANY HIO suspension or disqualification is in effect during the show for violation of any provision of the Horse Protection Act may not participate in this show in any capacity other than as a spectator. Prohibited activities include: showing or exhibition of horses, hauling horses to and from the show, or caring for horses on the grounds. Any suspended person must restrict themselves to the grandstand, rest room, and concession areas and may not linger were horses are kept.

22. Shoe sizes will be checked by the DQP only if there are questions brought by the judge, show management, or other exhibitors as to whether a horse is wearing shoes legal for the class the horse will be exhibited in. Please make sure the WHOA rules and show rules are reviewed to ensure horses are correctly shod for each division. There will not be an onsite farrier this year. There will be individuals who can do basic shoeing available at the show. In addition, the contact information of a local farrier will be available at the show office. There will also be a local vet contact information available at the show office.
23. **No chains or other action devices are allowed on any horses at any time on the show grounds.**
24. **Bands are not allowed on any horses at Oktoberfest at any time.**
25. The Northern California Walking Horse Association, Show Committee, Show Management and the Sonoma County Fairgrounds will not be responsible for any articles that are lost, destroyed or stolen, although every precaution will be taken to protect property and exhibitors. The show and/or management will not be liable for any injury sustained in any way to exhibitors, animals, employees or spectators. The warm up arena is not open to visitors; you must be an owner, rider, trainer, or groom to be in the area.
26. **Show Management reserves the right to accept or refuse service and/or deny entries and/or cancel entries, disqualify exhibitors, prohibit exhibition of entries and cancel premiums without claims for damage. Additionally, any individual who exhibits disorderly conduct or non-sportsman-like conduct may be asked to leave the grounds and all high points associated with that person (individual points or horse points) will be null and void. No refunds will be made to those who are asked to leave the grounds for disorderly conduct, non-sportsman-like conduct, or suspected HPA violations. BY YOUR PRESENCE ON THE SONOMA COUNTY FAIRGROUNDS AT THE OKTOBERFEST HORSE SHOW, EITHER AS AN EXHIBITOR OR A SPECTATOR, YOU AGREE TO ABIDE BY THE RULES AS LISTED .**

**Facility Rules:**

1. **The gates of the Sonoma County Fairgrounds will be closed at night. Entry to the grounds may be made through Gate 7 by entering the code #7720.**
2. **Stalls with nails left in them or dumping water buckets in the stalls will result in a \$25.00 charge assessed by the facility which will be passed on to the exhibitor. All manure must be dumped in the proper area.**
3. Please clean up after yourself and your horse. Areas left messy after the show will be charged to the organization and subsequently you will be billed for whatever the facility charges (Minimum \$40), plus an additional billing fee of \$30. You must leave the facility in the same condition that you found it.
4. Horses may only be washed in designated wash racks areas only.
5. The facility monitors closely to ensure there is no smoking in the arena or barn area of the facility. Show management will assist in enforcing this rule. **Anyone found smoking in these areas is subject to up to a \$500 fine and/or removal from the show.** Any fees charged to NCWHA resulting from a violation of this rule will be billed directly to the person at fault, along with the above mentioned fine.
6. Absolutely NO PARKING on the roadways or access ways is allowed on the fair grounds. All trailers & vehicles shall be limited to designated parking areas so as not to block the fire lanes. A tow truck may be called if there are violations.
7. Horses are only allowed in the barn, warm up arena and in the main arena only, **NOT ON THE GRASS.**
8. No riding in the barns, on the lawns or on the roadways.
9. **Dogs accompanying exhibitors and trainers must be kept on a leash at all times. Owners must clean up after their pet. If any complaints are filed, the pet will be required to be confined at all times.**
10. No riding of motorcycles, bicycles, ATV's or horses in the barns. Please observe the 10 MPH speed limit. Unlicensed drivers are not permitted to drive any motorized vehicle
11. You must leave the facility in the same condition as you found it. Landscape materials used outside your barn area must be removed and the area swept clean. **Vandalism, damage or displacement of Sonoma County Fairgrounds property or the property of any trainer, owner or exhibitors will result in a \$50.00 fine to all individuals involved in addition to any charges for damages.**
12. Grounds fees must be paid on any vehicle other than an auto or pickup without a camper left on the main show grounds, regardless of use of an electrical hook up. Horse trailers with occupants, motor homes and campers must display permits issued by the show office. All trailers and campers without displayed permits will be assessed the RV fee plus a \$10 service charge for failing to display your permit. There are a limited number of RV spots (Electric & Water ONLY) on the main show grounds. Please make arrangements with Kris Herman at [dr.kid@wineandwalkerranch.com](mailto:dr.kid@wineandwalkerranch.com) or 916-730-7720 ASAP. These spots will be issued on a first come first serve basis. In addition, law enforcement may be contacted in order to keep the peace and public safety for all individuals and animals. By attending the Oktoberfest Horse Show as an exhibitor, spectator, or guest, all individuals hereby agree to the rule and jurisdiction of the NCWHA, WIWHA, Sonoma County Fairgrounds, and Oktoberfest Horse Show.**
